• One Personal History completely filled out and signed as the same as the applicant's passport signature

5. Invitation Letter issued by educational institution in Thailand

- Must be an original invitation letter written in English (PDF or fax copy is not acceptable)
- Must have the letter head of educational institution
- Must address to "Royal Thai Consulate-General, Osaka"
- Must contain the applicant's name / parent or guardian's name / relationship between the applicant and parent or guardian / purpose of stay / date of entry / length of stay and type of visa
- Must have the official seal and include the autograph of the authorized representative (electronic signature is not acceptable)

6. Recommendation Letter issued by educational institution in Japan

- Must be an original Recommendation Letter written in English (PDF or fax copy is not acceptable)
- Must have the letter head of educational institution
- Must address to "Royal Thai Consulate-General, Osaka"
- Must contain the applicant's name / parent or guardian's name / relationship between the applicant and parent or guardian / purpose of stay / date of entry / length of stay and type of visa
- Must have the official seal and include the autograph of the authorized representative (electronic signature is not acceptable)

X In case that the Recommendation Letter from educational institution in Japan cannot be shown, an original guarantee letter must be presented together with a copy of guarantor's passport or driving license duly signed by the guarantor

Guarantee Letter (PDF)

- A guarantor must be twenty (20) years of age or older, must be able to confirm the applicant's personal attributes. A guarantor must be available to be contacted by the Consulate-General and must not be a person who will accompany the applicant to Thailand
- A guarantor who are not Japanese national must provide a copy of passport and residence card (front and backside) *Guarantor must be Japanese or non-Japanese who has permanent residence in Japan.)
- > A guarantor must sign as the same as the guarantor's identification document signature
- Japanese guarantor who prefers to use driver license, please sign as the same as signature in the guarantor letter on the copy of driver license (front and backside)

7. Official documents proving family relationship with the applicant

- For Japanese national, an original Household Registration issued within 3 months
- For Non-Japanese nationality, birth certificate of your country with English translation is required

8. One copy of the student's passport photo page

9. One copy of every page with Stay Permit stamps for Non-Immigration ED Visa in the passport of the student

10. One copy of confirmed airline ticket paid in full or ticket reservation confirmation

• The confirmed airline ticket paid in full or ticket reservation confirmation must be issued by airline or travel company and must contain the applicant's name, flight number and date arrival

11. In case that the student prefers to travel together with their parent or guardian on the same date, please not the following:

- Not required to submit the Document No. 9
- Must submit the visa applications of the Student and the parent or guardian on the same day
- Must travel to Thailand together on the same day
- Must submit one copy of confirmed airline ticket paid in full or ticket reservation confirmation of the student
