4. Personal History (PDF)

• One Personal History completely filled out and signed as the same as the applicant's passport signature

5. Invitation Letter issued by foundation/ association/ organization in Thailand

- Must be an original Invitation Letter written in English (PDF or fax copy is not acceptable)
- Must have the letter head of foundation/ association/ organization
- Must address to "Royal Thai Consulate-General, Osaka"
- Must contain the applicant's name / purpose of visit / date of entry / length of stay and type of visa
- Must have the official seal and include the autograph of the authorised representative (electronic signature is not acceptable)

In case that a signature of authorized person(s) in the letter of invitation is absent, a letter of power of attorney authorising other person(s) to act on his/her behalf must be submitted upon submitting the visa application

6. A copy of organization's registration issued by the competent authority of Thailand

7. Recommendation Letter issued by the current foundation/ association/ organization/ institute in Japan

- Must be an original Invitation Letter written in English (PDF or fax copy is not acceptable)
- Must have the letter head of foundation/ association/ organization
- Must address to "Royal Thai Consulate-General, Osaka"
- Must contain the applicant's name / purpose of visit / date of entry / length of stay and type of visa
- Must have the official seal and include the autograph of the authorised representative (electronic signature is not acceptable)
- ※ In case that the Recommendation Letter from foundation/ association/ organization/ institute in Japan cannot be shown, an original guarantee letter must be presented, together with a copy of guarantor's passport or driving license duly signed by the guarantor

Guarantee Letter (PDF)

- A guarantor must be twenty (20) years of age or older, must be able to confirm the applicant's personal attributes. A guarantor must be available to be contacted by the Consulate-General and must not be a person who will accompany the applicant to Thailand
- A guarantor who are not Japanese national must provide a copy of passport and residence card (front and backside) *Guarantor must be Japanese or non-Japanese who has permanent residence in Japan.)
- A guarantor must sign as the same as the guarantor's identification document signature
- Japanese guarantor who prefers to use driver license, please sign as the same as signature in the guarantor letter on the copy of driver license (front and backside)

8. One copy of confirmed airline ticket paid in full or ticket reservation confirmation

• The confirmed airline ticket paid in full or ticket reservation confirmation must be issued by airline or travel company and must contain the applicant's name, flight number and date arrival
