Overview	Duration of visa
<p>Applicants aged 50 years and over who wish to stay in Thailand for a period of not exceeding 10 years without the intention of working.</p> <p>*Applicants must be nationals and passport holders of the following eligible countries: Japan, Australia, Denmark, Finland, France, Germany, Italy, Netherlands, Norway, Sweden, Switzerland, the United Kingdom, Canada, and the United States.</p>	<p>5 years each time (a total of 10 years)</p>

Required Documents	
<p>The following documents must be uploaded in large and clear JPEG and PDF formats (the file size must not exceed 3MB)</p>	
1.	Biodata page of Passport or Travel Document
2.	Photograph taken within the last six months
3.	<p>Proof of the <b>permanent residence</b> in the country where the application is submitted :</p> <ul style="list-style-type: none"> <li>- Please submit a family registration (戸籍謄本) issued within 3 months for Japanese nationality.</li> <li>- Please submit a certificate of residence (住民票) issued within 3 months or a copy of the residence card for non-Japanese nationalities.</li> </ul>
4.	Financial evidence: A bank statement showing a balance of at least 3,000,000 THB in Thailand or a bank statement of at least 1,800,000 THB, and proof of annual income of no less than 1,200,000 THB.
5.	Medical certificates showing no prohibitive diseases (Leprosy, Tuberculosis, drug addiction, Elephantiasis, third phase of Syphilis) as indicated in the Ministerial Regulation No.14 (B.E. 2535) certificate shall be valid for not more than three months.
6.	Foreign Insurance Certificate as stipulated by the Office of Insurance Commission and Health Insurance of Thailand, which must be completed, signed, and stamped by the insurance company. The form can be downloaded from <a href="https://longstay.tgia.org">https://longstay.tgia.org</a>
7.	Health Insurance issued by an insurer in Thailand with outpatient benefits of no less than 40,000 THB and inpatient benefits of no less than 400,000 THB
8.	Certificate of criminal record clearance from the country of nationality or the country where the application is submitted. (Issue within 3 months).
