- A guarantor must be available to be contacted by the Consulate-General and must not be a person who will accompany the applicant to Thailand
- For Japanese guarantor who prefers to use a driver's license, please sign the same as the signature in the guarantor letter on the copy of the driver's license (front and backside)
- For non-Japanese nationals must provide a copy of passport and residence card (front and backside)
- In the English Guarantee Letter, a guarantor must sign the same as the guarantor's passport signature.
