

Visa Information

Please make an appointment online [VABO] (www.thaiconsulate-visa.jp/vabo/) for visa application.

1. The following visa applicants must apply and collect in person.

- Non-immigrant O-A and O-X visa applicant
- Non-Immigrant Media Visa
- Applicant(s) holding a temporary passport or re-entry permit to Japan, and applicant(s) holding a passport of the following countries:

*Applicants holding a passport of Nigeria are required to submit the Certificate of Clearance issued by the National Drug Law Enforcement Agency (NDLEA). The certificate must be legalized by the Ministry of Foreign Affairs of Nigeria and the Royal Thai Embassy in Abuja.

The above-mentioned passport holders without a valid residence card in Japan cannot apply for a visa at the Royal Thai Consulate-General, Osaka and Visa processing time for nationals listed above is approximately 3-60 days

2. Conditions for appointing a representative for visa application and collection

- If the applicant is under 20 years old or the applicant's parents make the application (Not required Authorization Letter for a family member)
- Non-immigrant B/O/ED visa applications and the collection for applicants affiliated with a company or an educational institute can be made by a representative of the applicant's company or institute, provided that the representative's business card and [authorization letter](#) are also submitted.
- Application and collection of visa not specified in No.1 can be made through the registered travel agency.
- The Royal Thai Consulate-General, Osaka reserves the right to require application and collection in person even though the applications meet the requirements.
 - The Royal Thai Consulate-General, Osaka may require additional documents and reserves the right to reject incomplete visa applications. The issuance of a visa is under the discretion of the Royal Thai Consulate-General, Osaka. The Royal Thai Consulate-General, Osaka is not obligated to explain visa rejections.
 - Fraud or misrepresentation can result in permanent visa ineligibility.
 - The Royal Thai Consulate-General, Osaka may require an interview; please plan your trip with sufficient time for visa processing. The applicant is strongly advised to apply for a visa at least two weeks ahead of departure time.
 - Payment in cash only, please prepare the exact amount of the visa fee.
 - The visa fee is non-refundable.
 - The application form and its related documents are unreturnable.
 - The Royal Thai Consulate-General, Osaka does not pre-screen applications and related documents before visa application.
